Mandatory Spay/Neuter law expanded to cover the Spears clan Los Angeles

In a press conference to explain the recent admission of Britney Spears to a Los Angeles area hospital, Mayor Antonio Villaragosa announced that the recently passed mandatory spay/neuter law for all dogs and cats in Los Angeles City had been expanded to cover the Spears family. All members of the Spears Clan will be required to be spayed or neutered by the age of 4 years to prevent the overcrowding of county orphanages. The Mayor stood together with Edwina Boks, the Chief Administrator of the city orphanages, in City Hall to announce that there has been a recent spike in the population of city orphanages and that the Spears family reproduction rate has been a major contributor to this crisis. "Britney has been the largest contributor so far, so she will be the first to be subjected to the new mandate" said the Mayor. Jamie Lynn will be next in line after the birth of her child and the children will be monitored carefully until they are four years old to be sure that they do not reproduce before they are neutered. Ms. Boks indicated that the fathers of the children may be considered for neutering under the new law and city attorneys are trying determining the paternity of Jamie Lynn's baby to help prevent further breeding.

Lynn and James Spears are being fined \$1 million for not obtaining the proper breeder permits for producing the Spears girls in the first place. Unfortunately, the Spears reside in a state known for harboring and encouraging baby mills so collecting the fine may be difficult. It is estimated that the City spends over \$50 million a year in housing and care for orphans and that placement of children produced by spoiled celebrities is particularly difficult because of their poor socialization and overall aggressive behavior. According to Ms Boks many of these children are ultimately deemed "un-placeable" and need to be transferred directly into the prison system for housing after they turn 18 years of age. Renowned child behaviorist Cesar Milan says that early spay/neuter has been show to quell their poor behavior and make them much more able to be integrated into society. Ms Boks admits that the closure of Neverland Ranch (Michael Jackson's rehabilitation facility for wayward celebrity children) was a great loss to the city orphanage system and the output of the Spears girls has just exacerbated the strain despite millions spent on new facilities in recent years. "This is a logical step to help get control of the problem and gives us a new tool in our efforts to provide the best for the young children of spoiled celebrities", added the Mayor.

There are exemptions for "Show Children", those who have preformed in an approved TV or Movie production (Direct to DVD will not count) or produced a Grammy winning album within the last year and continue to have viable careers beyond that. Also children that have forsaken the celebrity life, and have chosen meaningful careers in law enforcement or other service related occupations will be exempt. Celebrities may obtain a breeders permit and be allowed to have one child if they are members of an approved registering agency such as the Screen Actors Guild. Children who are too ill for the procedure and obtain a letter from a board certified physician (plastic surgeons will not qualify) may also be exempt, but must be re-certified every six months until they healthy enough to undergo the procedure, or have met one of the other exemptions. Judy Mancuso, director of the Coalition for Healthy Celebrities, hailed this as a victory for all tax paying, law abiding citizens of Los Angeles and hopes to take this law to the many other areas with celebrity overpopulation problems in the near future to ultimately stem the tide of greedy celebrity breeders and save millions of tax payer dollars.
